## **THE PRESIDENT'S COLUMN**

Dear Friends,

Each day the relevance and importance of the Houston Metropolitan Research Center's archival collections to the preservation of Houston's historical thread becomes more apparent. Landmarks in the built environment succumb to the wrecking ball daily, and major intersections, which have looked the same for decades, suddenly are unrecognizable. Native Houstonians like me, who were accustomed to using buildings rather than street signs to navigate around the city, suddenly don't know where they are.

At the HMRC one learns that it has been ever thus! Houston always has been about the future, about progress, and about embracing the newest styles. The fates of two of the city's great nineteenth century houses are cases in point. The John Henry Kirby house at 2006 Smith Street (built 1893 / '94) has been described as "probably Houston's most complete domestic response to the Gilded Age." Nevertheless, in 1925, in anticipation of entertaining dignitaries who would be in Houston for the 1928 Democratic National Convention, Mr. Kirby tore down most of the house and incorporated the foundation into the state-of-the-art 1920s house which fortunately still stands. He wanted to show the nation that Houstonians were up to date.

Eugene T. Heiner, one of Houston's most prominent 19th century architects, designed the Charles Shearn House at 1806 Main Street at Jefferson Avenue. Built in 1882, it has been described as probably "Houston's best example of American Victorian interpretation of the French Second Empire style." About 1914 the house became the first home of the Houston Art League, forerunner of the Museum of Fine Arts Houston. In 1916, the President of the Art League described the house as an "architectural monstrosity." It was demolished c. 1919 to make way for one of the Humble Company's first gas stations.

Today our nation seems to be in the grip of an historical identity crisis. Controversy overshadows even our most venerated historical persons, institutions, and monuments. Today the Shearn House would be hailed as an architectural masterpiece by many, but others would denounce it as a symbol of privilege and excess. In the current atmosphere of divisiveness and confusion, I am grateful for the HMRC where one can find the primary sources from which one can make up one's own mind about the facts. This is an indispensable tool in maintaining our democracy. Thank you for being a part of it.

## **MINUTES OF THE MAY 4th, 2015, GENERAL MEETING**

President Dorothy Knox Houghton called the meeting to order at 7:00 p.m. She introduced the evening's speaker: Dr. William Kellar, author of *Enduring Legacy: the M.D. Anderson Foundation and the Texas Medical Center*, who gave a fascinating presentation on "Monroe Dunaway Anderson's Enduring Legacy." He spoke of two sets of brothers, Frank and Monroe Anderson and William Clayton and Benjamin Clayton, who together founded Anderson, Clayton and Company in 1904, a cotton brokerage firm, which eventually was based in Houston.

The M.D. Anderson Foundation was organized June 9th, 1936, with initial capitalization of \$10,000 contributed by Monroe Anderson who continued to make contributions totaling approximately \$300,000 until his death in 1939. Throughout his life he met frequently with the other Trustees, and upon his death some \$19 million of his estate went to the Foundation.

Upon passage of state legislation to create a cancer hospital somewhere in the state of Texas in 1941, the Foundation offered to match the state's fund of \$500,000 and provide twenty acres of land for a hospital. Based on this offer, legislators selected Houston, and in 1954, the M.D. Anderson Hospital for Cancer Research at the University of Texas opened.

Its first director, Dr. Ernst William Bertner, had treated a family member in New York and was persuaded by Mr. Anderson to come to Houston to head the hospital. He later became the first Director of the Texas Medical Center and is considered the father of TMC. Among other things, Dr. Kellar alluded to the fact that the last baby delivered by Dr. Bertner was Denton A. Cooley. Illustrating how dreams can surpass the greatest expectations, Dr. Kellar noted that the TMC has grown from the original 134 acres to encompass some 1,300 acres, and that "in the first 75 years, the M.D. Anderson Foundation gave away \$276 million in grants."

## **NEWS FROM THE TEXAS ROOM**

The HMRC is currently working on a cooperative grant project with the Houston Area Library Automated Network, the Harris County Archives and its library partner the Harris County Public Library, the University of Houston Libraries' Special Collections, and the Woodson Research Center at Rice University's Fondren Library. The goal of this year's grant is to create a model for community collaboration that increases the community's

awareness of the Astrodome Memories Project and its archival partners. Grant activities include developing a process to allow the community to submit their scanned memorabilia and memories to the Astrodome Memories website (<http://www.astrodomememories.org>); having four community events that promote the project; developing one or two curriculum modules to teach school children about the Astrodome; and increasing the visibility of the project online with social media marketing.

The next public program will be an oral history and scanning event held on **Saturday, August 8th, from 10:00 a.m. - 2:00 p.m. in the Julia Ideson Building Auditorium.** Oral histories and items scanned at the event will be shared online on the project website. Please see the Astrodome Memories website and the Houston Public Library events calendar for more information about this and upcoming events.

Another grant funded project involves a partnership between the HMRC and the City of Houston Planning Department's GIS division, to create ten interactive maps representing most decades in Houston's history with 1,000 geocoded points representing significant landmarks in Houston's growth and history. The grant will enable the scanning of additional objects representing events, architectural monuments and historical and cultural landmarks in the city's history associated with the geocoded landmarks. The online interactive maps will be made live when the website is officially launched in the fall of 2015.

In addition, the HMRC is proud to announce we were awarded the National Endowment for Humanities (NEH) Latino Americans Grant. The HMRC will use this funding for the upcoming Hispanic Heritage Month fall series "Hispanic Heritage Heroes: From War and Peace to Prejudice and Pride." The month's activities will begin with the opening of "Remembering World War II: Houston's Latino Veterans," an exhibition of documents and photographs from the Hispanic Archival Collections housed at the HMRC. Other activities include a World War II lecture series, supplementary exhibit of paintings inspired by the history of the Bracero Program, and a children's series dedicated to teaching Houston youth about local veteran and hero Staff Sgt. Macario Garcia.

### **A. Contributions**
