## **THE PRESIDENT'S COLUMN**

Dear Friends,

Over the past thirteen years, the Friends of the Texas Room has supported the Houston Metropolitan Research Center through public advocacy and through tangible gifts. In the preliminary meetings which led to the restoration of the Julia Ideson Building, we brought to the attention of the city the existence of the original architectural plans for what has become the new architectural wing which now houses the Texas Room and the HMRC. We then participated in the planning phase for the restoration of the 1926 building and the construction of the new archives.

We produced a documentary program based on the collections in the HMRC entitled *In Search of Houston's History*. The program aired on Channel 8 and won a Good Brick Award from the Greater Houston Preservation Alliance. It presents a capsule history of Houston while highlighting the library's holdings. We donated copies of the DVD to all Houston Public Schools, and we sell them for \$30 each. All proceeds are used to support the HMRC.

We have purchased microfilm storage cabinets, atlas stands, and custom-made plinths for the vintage exhibit cases. We have funded scholarships to student summer interns at the library and expenses related to a research program on the Astrodome. We are funding a soon-to-be-activated cell-phone tour of the Julia Ideson Building among many other donations.

All of these contributions have been funded by your membership dues and by matching gifts from companies for whom our members and volunteers work. Your support has made an enormous difference in the quality and extent of service the HMRC is able to offer the Houston community. In a few weeks you will be receiving your membership renewal notice. The HMRC counts on us to supplement their budget from the city. We look forward to your continuing involvement in this effort. Many thanks!

## **MINUTES OF THE JULY 27th, 2015, GENERAL MEETING**

President Dorothy Knox Houghton called the meeting to order at 7:00 p.m.

She encouraged members in attendance to submit nominations for Board membership. She then introduced Nancy Burch who, in turn, introduced the speaker for the evening, Steve Smith, a long time Houston based television anchor.

Mr. Smith talked about his career and experiences living in Houston. Born in Indiana, he took his first job as a tele-journalist in 1964 before being invited by the legendary Ray Miller to join Channel 2 in 1966. He joked self-deprecatingly about his deep resonant voice that was the hallmark of his career, giving credit to a parochial school nun, Sister Mary Claire, who encouraged him to pursue public speaking. He noted that his first day on the job was August 1<sup>st</sup>, 1966, the day Charles Whitman killed a number of people from the balcony of the tower at the University of Texas Library.

After a brief hiatus away from Houston, he spent the balance of his career, 23 years, in Houston and recalled trips accompanying the Houston Symphony to Vienna and the Houston Grand Opera to Cairo, along with a stint reporting on the fall of the Berlin Wall in 1989 as highlights.

Following his presentation, he graciously took questions from the audience. When asked about his experience covering inclement weather, he described traveling to report on Hurricane Camille and acknowledged “standing in water” while filming some of his reports which were sent back to Houston as raw film handed to flight attendants at the airport with the request that they hand carry them to Houston and call the station to pick them up. My, how times have changed.

## **NEWS FROM THE TEXAS ROOM**

Over the summer we welcomed a new Architectural Archivist to the position formerly held by Jennifer Sessa, the current HMRC Assistant Manager and Lead Archivist. Samantha Bruer was selected to fill this challenging yet immensely rewarding and invaluable role.

Samantha graduated with an undergraduate degree in historic preservation from Southeast Missouri State University in August 2012. While at Southeast she worked one year in the university archives digitizing yearbooks using CONTENTdm. To

further her archival skills, she also interned at South Union Shaker Village. During the internship, she created and organized digital surrogates of several thousand photographs in the historic site's collections.

In graduate school at Western Kentucky University, she worked as a graduate assistant to the archivist of Mammoth Cave National Park. There she processed collections of park employees' records according to significance and the NPS record disposition schedule and entered record data and created finding aids using Re: discovery ICMS. She also worked on several collections that included architectural and other oversize records. As part of her training, she also took a class in archival procedures and completed volunteer hours in the university archives.



Samantha has essentially “jumped right in” to the work and has eagerly embraced her new role. One of her early projects involved making improvements to the architecture-related vertical files including merging, organizing, and adding content to make these more accessible and useful for customer research. “Already I’m seeing how beneficial the information will be to patrons with interests in particular people, early Texas architecture, and Houston’s development from a small town to prominent city”.

She is currently working on several ongoing projects including updating descriptions and sheet counts for architectural records to enhance accessibility, as well as providing some needed preventive conservation measures to ensure long-term preservation of the collection including rehousing, replacing non-archival fasteners, and prioritized materials to be conserved in-house. She has also completed archival processing for the Roy W. Leibsle Collection (MSS 0139) and will soon begin working on the Esperson Building Collection (RG D 0001). She has made significant strides in learning how materials are processed at HMRC according to accepted archival standards.

Samantha also recently assisted with an event that was sponsored by Preservation Houston as a part of their Pier and Beam program. This particular event was held in the Texas Room and was coordinated by HMRC staff with the goal of instructing the attendees in how to research properties and neighborhoods utilizing the Texas Room and HRMC resources. The Architectural Archivist at HMRC regularly assists with this type of research and is charged with providing in-depth references service based on knowledge the collection and the subject, as well as facilitating access to any other resources that may be available.

We are thrilled to have the skills, experience, and enthusiasm that Samantha brings to this position. We know she will be a great asset to the HMRC team!

Relating to The Houston Metropolitan Research Center which includes the Collections of the Archives and Manuscripts Department, the Texas and Local History Department, and the Special Collections Department of the Houston Public Library

### **A. Contributions**

From time to time, the Friends of the Texas Room will purchase and contribute to the Houston Metropolitan Research Center of the Houston Public Library items that will enrich and enhance the above-named collections and ensure their preservation.

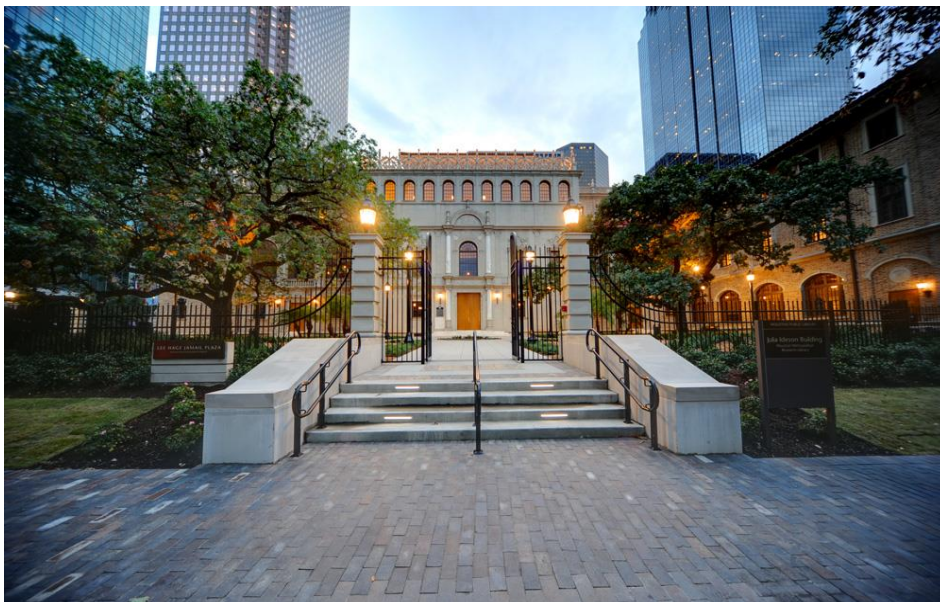
