THE PRESIDENT'S COLUMN

Dear Friends,

We have much to celebrate! I hope that all of you will join us on November 17th for the reception in the restored Julia Ideson Building hosted by the Julia Ideson Library Preservation Partners. You will receive an invitation in the mail, but the details also are posted in this issue of the Dispatch. The Friends have played a major role in bringing about the building of the new archival wing and the restoration of the 1926 building. Now it is time for revelry!

Adding to the festivities on November 17th will be the presentation of the 2011 Julia Ideson Award to Steven R. Strom for his book, Houston Lost and Unbuilt, and of the honorable mention award to Wesley G. Phelps for his doctoral dissertation, "A Grassroots War on Poverty: Community Action and Urban Politics in Houston, 1964-1976." We are placing a brass plaque commemorating all of the winners of the Julia Ideson Award on a wall in the new Texas Room.

I am happy to report that we have given a beautiful life-size copy (35" x 50") of the 1867 Kosse and Scott map of Houston to the HMRC in honor of Kemo Curry. (Theodore Kosse was a civil engineer for the Houston and Texas Central Railroad.) An original copy of this map, owned by the HMRC, is in very bad condition. Our gift will now serve as the HMRC's working copy so that their original can be preserved. The original map from which our gift copy was made is for sale at Arader Galleries for \$75,000!

Once the opening festivities are over, the HMRC is hoping that the Friends will provide regularly scheduled docents to give tours of the Ideson Building. These docents will be trained by the HMRC staff. The HMRC staff continues to use our DVD in teacher inservice training.

When our organization was founded in the spring of 2003, there were no plans for the restoration of the Ideson Building, much less any thought of building the new wing. The future of the HMRC was not at all clear. The events that have transpired since then seem almost miraculous. Our organization has played an important part in bringing this about. Our membership should be very proud of its accomplishments and look forward to exciting and rewarding times ahead.

MINUTES OF THE July 25th, 2011, GENERAL MEETING

The Friends of the Texas Room met at the Museum of Printing History, 1324 W. Clay St., on July 25, 2011. After a brief reception and refreshments, President Dorothy Knox Houghton called the meeting to order at 7:03 PM. A motion was made, seconded and approved to dispense with the reading of the Minutes of the April 25th, 2011 members' meeting.

Treasurer Cathy Fitch reported that the funds on hand, including the checking account, the savings account, and the 14 month CD total \$35,971.27. President Houghton encouraged those in the audience who are not members of the Friends of the Texas Room to obtain a membership form before leaving the Museum and join the organization.

President Houghton introduced third generation Houstonian and photojournalist J. R. Gonzalez, News Copy Editor at the *Houston Chronicle* and author of "Bayou City History Blog" at chron.com. Mr. Gonzalez's topic was entitled "Bayou City History – Exploring Houston's Past Through Photojournalism." His program included slides of familiar landmarks and citizens of the city of Houston as well as noted personalities who had visited the city. He successfully encouraged the audience to reminisce about their experiences at the pictured landmarks and recollections of some of Houston's eminent civic leaders. At the end of the presentation Mr. Gonzalez encouraged the audience to visit his display in the Print Museum featuring photos of local personality Marvin Zindler. Some of these photos will be auctioned with the proceeds benefiting Houston Arts and Media and the Print Museum.

Jeff Lindemann gave an update of the past programs addition to the web site: friendsofthetexasroom.org. The first such addition was the presentation by Betty Chapman at the April 25th, 2011 General Meeting.

Julia Ideson Award Chairman Barbara Eaves announced that 8 entries consisting of two videos, one magazine, and five books had been received and were in the process of being reviewed by judges John Boles, Michael Botson, and Doris Glasser. The winner will be chosen by October 1st and the award presented at the October General Meeting. Mrs. Eaves reminded the audience that the criteria for the award included the requirement that research is done using the resources of the Houston Metropolitan Research Center and that it document local or Texas history or culture.

Bill Kellar, former Friends secretary, and member of the Houston Historical Association outlined the activities associated with the celebration of Houston's 175th birthday. On October 29th, experts on Houston will give presentations between 8:30 am and 3:30 p.m. focusing on the reasons settlers came to Houston. The session is entitled "Milestones and Arrivals." This history conference will take place at the University of

Houston Hilton Hotel and the fee is \$50.00. Organizations are encouraged to set up and staff booths. A “History Crawl” will take place at various venues throughout the city from August, 2011 – June, 2012.

Audrey Barrett Cook will speak September 10th, 2011, 10:00 a.m. at Lanier Middle School on Obedience Smith and preside over the dedication of a marker to Obedience Smith.

President Houghton announced that Liz Sargent, acting director of the Houston Metropolitan Research Center, is asking for volunteers to conduct tours of the Julia Ideson facility. Interested members can contact President Houghton for further information.

President Houghton reminded the audience that Friends of the Texas Room brochures and DVD’s were available.

There being no additional business, the meeting adjourned at 8:00. PM.

POLICIES

Policies of the Friends of the Texas Room

Relating to The Houston Metropolitan Research Center which includes the Collections of the Archives and Manuscripts Department, the Texas and Local History Department, and the Special Collections Department of the Houston Public Library

A. Contributions

From time to time, the Friends of the Texas Room will purchase and contribute to the Houston Metropolitan Research Center of the Houston Public Library items that will enrich and enhance the above-named collections and ensure their preservation.

All such contributions will be purchased by the Friends directly and then given to the Library with specific stipulations as to how such contributions are to be used by the Library to enhance and ensure the preservation of the HMRC collections.

The Friends will give no money directly to the Library.

The Friends will not buy expendable supplies for the Library.

The Friends will not fund Library personnel.

B. Relationship to Administration and Staff

The Friends of the Texas Room is not to be involved in the administrative or employee actions of the Center, except that the Friends can question policies which, in its opinion, negatively impact the ability of the Center to provide service to the public.

CULTURAL MATCHING GIFTS

Are you or your spouse working for or retired from a corporation which makes cultural matching grants or volunteer involvement awards if you give to or do volunteer work for a cultural institution?

Will your employer match your gifts to cultural institutions that qualify under Section 501(c)(3) of the Internal Revenue Service Code?

The Friends of the Texas Room has such a qualification. Send your corporation's cultural matching funds form with your check for membership in FTR. If you volunteer your time as an officer of FTR or in the Texas Room or HMRC, keep track of your hours and turn them in to your corporation so that the FTR may obtain a grant from your corporation's program. This is "found money" for FTR and can be used towards making a difference to the Texas Room and HMRC.


