Dear Friends,

Thanks to the Harris County Heritage Society, our DVD, "In Search of Houston's History," is now being used by seventh grade social studies teachers in forty-five schools in HISD and surrounding school districts. Recently the Heritage Society held its 2010 Texas History Teachers Workshop to which the Friends provided free copies of the DVD for all interested participants.

On Thursday, October 7, FtxR board member Jeff Lindemann; HMRC Manager, Kemo Curry; and HMRC archivist, Liz Sargent made a presentation about the HMRC to the Social Studies Advisory Committee of the Texas Education Agency's Region IV. The members of the Social Studies Advisory Committee are the district co-ordinators for social studies in the greater Houston area. They will report back to their school districts about the conference, and the Friends gave each one a copy of the DVD to show to their teachers.

Many of those teachers will attend the Region IV Social Studies Conference on January 22, 2011, where Jeff, Kemo and Liz will show them how they can incorporate the DVD into their curriculums. The Friends will provide copies of the DVD to all interested teachers.

Our DVD is proving to be a wonderful tool for introducing the HMRC to the teachers and students in the greater Houston area while also introducing them to our local history. If you have a special connection with a school where the DVD might be incorporated into the curriculum, please let us know. We also have the DVD for sale to the general public at \$30 per copy. It makes a wonderful gift for anyone interested in Houston's history.

### **MINUTES OF THE July 26<sup>TH</sup> , 2010, GENERAL MEETING**

The July 26, 2010 general meeting of the Friends of the Texas Room took place at the Museum of Printing History. It was called to order at 7:00 P. M. by the president, Dorothy Knox Houghton, following a lovely reception provided by Mary Jo Coselli, JoLee Haddock, Barbara Eaves, and Martha Lou Broussard.

Mrs. Houghton introduced the speakers for the evening, Laney McAdow and Mary McMillen, staff members of the HMRC. Their topic was "Preservation Techniques for Family Archival Treasures." Their talk included the conservation and preservation strategies for books, documents, letters, newspapers, leather and photographs. They demonstrated some of the techniques for protecting and prolonging the life of these kinds of materials through the use of various archival quality supplies.

The program was followed by a brief business meeting. The minutes of the general meeting on April 26, 2010 were approved as circulated in the newsletter.

The Treasurer, Cathy Fitch, reported total funds on hand of \$34,277.35.

Mrs. Houghton reported that Board Director, Sharon Dies, had had to resign in order to become the Chairman of the Bayou Bend Docents. The Friends Board had decided that since the annual meeting of the Friends was coming up in three months, we could wait to replace her at that time.

Mrs. Houghton reported that our wonderful Membership Chairman, Dorothy Johnson, will be retiring in December. Therefore, we need someone to step into her shoes.

The annual meeting and announcement of the 2010 winner of the Julia Ideson Award will take place at the Museum of Printing History on Monday, October 25, 2010, beginning at 6:30 P. M.

There being no further business, the meeting was adjourned at 8:00 P. M.

#### **Policies of the Friends of the Texas Room**

Relating to The Houston Metropolitan Research Center which includes the Collections of the Archives and Manuscripts Department, the Texas and Local History Department, and the Special Collections Department of the Houston Public Library

#### **A. Contributions**

From time to time, the Friends of the Texas Room will purchase and contribute to the Houston Metropolitan Research Center of the Houston Public Library items that will enrich and enhance the above-named collections and ensure their preservation.

All such contributions will be purchased by the Friends directly and then given to the Library with specific stipulations as to how such contributions are to be used by the Library to enhance and ensure the preservation of the HMRC collections.

The Friends will give no money directly to the Library.

The Friends will not buy expendable supplies for the Library.

The Friends will not fund Library personnel.

### **B. Relationship to Administration and Staff**

The Friends of the Texas Room is not to be involved in the administrative or employee actions of the Center, except that the Friends can question policies which, in its opinion, negatively impact the ability of the Center to provide service to the public.

### **CULTURAL MATCHING GIFTS**

Are you or your spouse working for or retired from a corporation which makes cultural matching grants or volunteer involvement awards if you give to or do volunteer work for a cultural institution?

Will your employer match your gifts to cultural institutions that qualify under Section 501(c)(3) of the Internal Revenue Service Code?

The Friends of the Texas Room has such a qualification. Send your corporation's cultural matching funds form with your check for membership in FTR. If you volunteer your time as an officer of FTR or in the Texas Room or HMRC, keep track of your hours and turn them in to your corporation so that the FTR may obtain a grant from your corporation's program. This is "found money" for FTR and can be used towards making a difference to the Texas Room and HMRC.

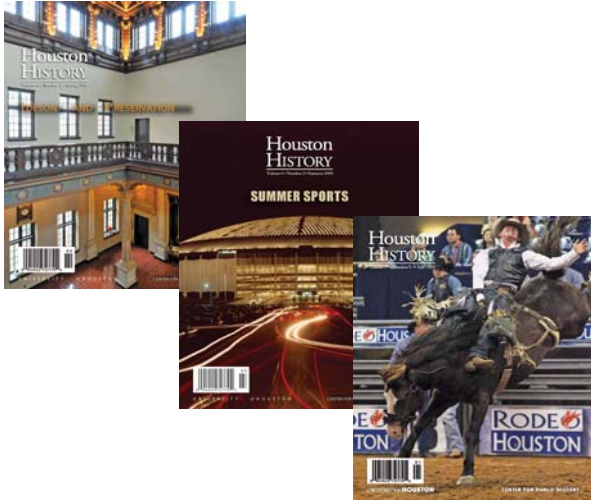
